

MOBILE APP PRIVACY POLICY

Last Modified: April 4, 2018

1. INTRODUCTION

We Wash Car, Inc. (“We Wash”) respects your privacy and is committed to protecting it through our compliance with this policy. This policy describes:

- The types of information we may collect or that you may provide when you download, access or use the We Wash app (the “App”), and through any electronic communications in connection with the App.
- Our practices for collecting, using, maintaining, protecting and disclosing that information.

This policy applies only to information we collect in this App and in email, text, and other electronic communications in connection with this App. This policy DOES NOT apply to information that you provide to or is collected by any third party. These third parties may have their own privacy policies, which we encourage you to read before providing information on or through them.

Please read this policy carefully to understand our policies and practices regarding your information and how we will treat it. If you do not agree with our policies and practices, do not download, register with, or use this App. By downloading, registering with, or using this App, you agree to this privacy policy. This policy may change from time to time. Your continued use of this App after we make changes is deemed to be acceptance of those changes.

2. INFORMATION WE COLLECT AND HOW WE COLLECT IT

We collect information from and about users of our App directly from you when you provide it to us, and automatically when you use the App.

2.1 INFORMATION YOU PROVIDE TO US

When you download, register with, or use this App, we may ask you provide information:

- By which you may be personally identified, such as name, postal address, email address or telephone number (“Personal Information”).
- That is about you but individually does not identify you, such as your car’s make and model, license plate, and its location.

This includes:

- Information that you provide by filling in forms in the App, including information provided when you register for the App. We may also ask you for information when you enter a contest or promotion sponsored by us, and when you report a problem with the App.

- Records and copies of your correspondence (including email addresses and phone numbers), if you contact us.
- Details of transactions you carry out through the App. You will be required to provide financial information before ordering services through the App.

2.2 AUTOMATIC COLLECTION OF INFORMATION

When you download, access and use the App, it may use technology to automatically collect real-time information about the location of your device. You can choose whether or not to allow the App to collect and use such information through your device's privacy settings.

We do not collect personal information automatically, but we may tie this information to personal information about you that we collect from other sources or from you.

2.3 INFORMATION COLLECTION TECHNOLOGIES

The technologies we use for automatic information collection may include cookies, or mobile cookies. A cookie is a small file placed on your smartphone. It may be possible to refuse to accept mobile cookies by activating the appropriate setting on your smartphone. However, if you select this setting you may be unable to access certain parts of our App.

3. THIRD PARTY INFORMATION COLLECTION

We may provide information to our business partners in order to process payments for our services.

When you use the App or its content, certain third parties may use automatic information collection technologies to collect information about you or your device. These third parties may include:

- Advertisers, ad networks and ad servers.
- Analytics companies.
- Your mobile device manufacturer.
- Your mobile service provider.

These third parties may use tracking technologies to collect information about our users. This may include information about users' use of this App and other apps or websites to serve them interest-based advertising. We do not control these third parties' tracking technologies or how they may be used. If you have any questions about an advertisement, you should contact the responsible advertiser directly.

4. HOW WE USE YOUR INFORMATION

We use information that we collect about you or that you provide to us, including location information and Personal Information, to:

- Provide you with the App and its contents, and any services that you request from us.
- Carry out our obligations and enforce our rights arising from any contracts entered into between you and us, including for billing and collection.
- Notify you when App updates are available, and of changes to any products or services we offer or provide through it.
- Fulfill any other purpose for which you provide it.

The usage information we collect helps us to improve our App and to deliver a better and more personalized experience by enabling us to:

- Estimate our audience size and usage patterns.
- Store information about your preferences, allowing us to customize our App according to your individual interests.
- Speed up your searches.
- Recognize you when you use the App.

5. DISCLOSURE OF INFORMATION

We may disclose non-identifying information about our users without restriction.

In addition, we may disclose information that we collect or you provide:

- To contractors, service providers and other third parties we use to support our business and who are bound by contractual obligations to keep personal information confidential and use it only for the purposes for which we disclose it to them.
- To comply with any court order, law or legal process, including to respond to any government or regulatory request.
- To enforce our rights arising from any contracts entered into between you and We Wash, including the App Terms & Conditions, and for billing and collection.
- If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of We Wash, our customers or others.
- For any other purpose disclosed by us when you provide the information.

6. YOUR CHOICES ABOUT OUR COLLECTION, USE AND DISCLOSURE OF YOUR INFORMATION

We strive to provide you with choices regarding the personal information you provide to us. You can choose whether or not to allow the App to collect and use real-time information about your device's location through the device's privacy settings.

7. CHANGES TO OUR PRIVACY POLICY

We may update our privacy policy from time to time. If we make material changes to how we treat our users' Personal Information, we will post the new privacy policy on this page and notify you by in-App alert the first time you use the App after we make the change.

The date the privacy policy was last revised is identified at the top of the page. You are responsible for periodically visiting this privacy policy to check for any changes.
